## **ORDINANCE 2020-7**

## AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR 2020

**WHEREAS**, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and

**WHEREAS**, Public Act 101-0627 required the Mt. Zion Police Pension Fund to reclassify previously classified Tier 2 members as Tier 1, resulting in increased pension benefits, and

**WHEREAS**, the Village of Mt. Zion desires to increase the budget for the Police Pension Fund in order to cover expenses incurred during the fiscal year, and

**WHEREAS**, the budget for the Police Pension Fund will spend more funds than was appropriated by Ordinance 2019-25, and

**WHEREAS**, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the Police Pension Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

**Section 1**: That total expenditures appropriated for the Police Pension Fund will be increased from \$88,400.00 to \$123,400.00 for Fiscal Year 2020.

Section 2: Ordinance No. 2019-25 is hereby amended.

**Section 3:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
