## ORDINANCE 2022-10

## AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR 2022

**WHEREAS**, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and;

**WHEREAS**, the General Fund has higher than expected revenues for Fiscal Year 2022 and the fund balance is more than sufficient and exceeds expenditures to-date, and:

**WHEREAS**, the corporate authorities desire to purchase a 2017 Ford F350 Pick-up Truck to replace a 1999 Dodge Ram 2500 with 113,205 miles, and

**WHEREAS**, with the purchase of the 2017 F350 Pick-up Truck the corporate authorities desire to increase the General Fund – Street Department – Vehicle line item by \$59,000 and increase the funds appropriated by Ordinance 2021-24, and;

**WHEREAS**, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the General Fund – Street Department by \$59,000 to \$1,536,500;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

**Section 1**: That total expenditures appropriated for the General Fund – Street Department will be increased from \$1,477,500 to \$1,536,500 for Fiscal Year 2022.

Section 2: Ordinance No. 2021-24 is hereby amended.
